5 PLANNING SCHEDULE

- 5.1 To consider the following new planning applications:

Application for Approval of Reserved Matters following Outline Approval 09/00971/OUTMAJ Redevelopment of Newbury Racecourse to provide new and enhanced leisure, racing, administrative, and visitors facilities; new hotel and hostel; replacement children's nursery; the permanent retention of the Mill

Reef Stand; replacement maintenance buildings, yard and workshops; replacement golf club house and apartment, floodlit driving range and remodelling of the golf course; up to 1,500 dwellings; local centre; combined heat and power district heating system; new and improved accesses; parking for visitors, staff and residents; open space and landscaping, signage, service infrastructure, and associated uses (minor changes to application 08/02201/OUTMAJ). Matters to be considered: Appearance, Landscaping, Layout and scale.

This is to inform you that additional drawings/amended plans for the above application have been received by the Council.

Greenham Parish Council resolved to **Object** on the following points.

- Privacy Issues, the proposed development will overlook onto already neighbouring gardens.
- The new development is not in keeping with the current street scene.
- There are inadequate parking facilities, forcing vehicles to park unsafely along the road
- This proposed development will eliminate open green space. Cllr. Jones proposed, Cllr. Drummond seconded and all in favour.
- 23/02667/RESMAJ History 2, Newbury Racecourse, Racecourse Road, Newbury. Application for Approval of Reserved Matters following Outline Approval 14/03109/OUTMAJ Section 73: To vary condition 32: No more than 250 dwellings shall be completed prior to the completion and opening to traffic of a new bridge, to 421 dwellings. Of approved reference 09/00971/OUTMAJ for redevelopment of Newbury Racecourse to provide new and enhanced leisure, racing, administrative and visitors facilities; new hotel and hostel; replacement children's nursery; permanent retention of the Mill Reef Stand; replacement maintenance buildings, yard and workshops; replacement golf club house and apartment, floodlit driving range and remodelling of golf course; up to 1,500 dwellings. Matters to be considered: Appearance, Landscaping, Layout and scale.

Cllr. Drummond, Cllr, Puffett, Cllr. Neal, and Cllr. Blackborow agreed to be in the working group. Cllr. Barnett will also be invited to this meeting who was not in attendance.

A meeting will be arranged in the next two weeks.

9 COMMUNITY PARISH ASSEMBLY – 25 APRIL 2024, GREENHAM CONTROL TOWER, 7PM

The Clerk updated Council on the final arrangements. It was agreed to purchase pin badges for Council members. It was considered that next year a display could be shown regarding Parish Councils involvement in the history of Greenham Control Tower. Facebook (paid) posts had reached 2,114 public and had 13 event responses. An advert will be in the Newbury Weekly News on Thursday 18th April.

10 CLERK CORRESPONDENCE

Bus Shelter, Racecourse

West Berkshire Council confirmed that they would clear the broken glass from the bus shelter glass panel outside the rocking horse at the Racecourse. Cllr Sanderson to check that this had been done.

Dog Waste Bins

Tactical Management reported that three bins had been graffitied in the parish, the cost for this would be £30 to clean the bins when being emptied, the clerk said this was cheaper than Expenditure. It was agreed to accept the quote. Cllr. Cllr. Jones proposed and Cllr. Swift-Hook seconded, all in favour.

The Clerk said she would continue to talk to WBC and Continental (WBC Dog Waste Contractors) regarding the dog waste bins overflowing on the Common. Cllr. Drummond said to copy him into the email correspondence. The Clerk said that WBC had acknowledged emails but nothing had appeared to change and bins were still overflowing.

Greenham and Crookham Common Commission (GCCC) Election

The Commission is obliged to hold Commoner elections every 3 years, and 2024 is an election year. All Commoners have been written to and a notice will also appear in the Newbury Weekly News on the 11th and 18th April 2024. Please see the <u>GCCC website</u> for more details.

Unity Trust Bank has now sent out instructions for authorised signatories to log onto online banking.

Benches

It was confirmed that a memorial bench was found abandoned in the woodlands near the water tower in Pigeons Farm. Cllr. Drummond said to forward the information on to him as he was aware where the bench was originally situated.

It was reported also that the memorial bench on Stroud Green had been damaged. It was unclear if it was just the installation that needed repairing, or the bench itself. Cllr. Jones said he would investigate and report back to Parish Council. If it was the installation. The Clerk would notify WBC as they had only recently installed the bench that GPC purchased.

Police

The Clerk had contacted Thames Valley Police to ask if they held quarterly meetings that Council members could attend to engage more with them. This was raised in the last community engagement meeting. They said they were not aware of any such meetings. Communities run their own Neighbourhood Action Groups (NAG) that police members sometimes would attend. Greenham NAG was disbanded many years ago, but if Greenham did start one up again then to contact TV police and they would try and attend when they could. {The Clerk also noted that she had not received any confirmation from the police to attend the forthcoming Assembly when they had been invited}

11 CHAIRMAN REPORT

Cllr. Jones received an email from a member of the public regarding the uneven ground on the Common. He had replied to say that the Common is managed by WBC and BBOWT (Berkshire, Buckinghamshire, Oxfordshire Wildlife Trust) and asked the Clerk to forward the email to them.

12 DISTRICT COUNCILLORS REPORT

Cllrs. Drummond and Barnett had attended the hearings for Planning Application Sandleford development.

13 PARISH COUNCILLORS' REPORTS

Cllr. Blackborow said that Car Park volunteers are needed for the D-Day Event on 6th June for the Greenham Control Tower Car Park. If anyone could help to let Cllr. Blackborow know.

The D-Day event led onto a discussion of using the Control Tower's Beacon. Cllr. Puffett to forward more details to the appropriate people to investigate.

The Clerk noted that the Beacon was not on the Greenham Asset Register.

14 CO-OPTION OF NEW MEMBER TO COUNCIL

Following an application from Mrs Kim Harrison. Mrs Harrison was invited to attend this meeting. Cllr. Swift-Hook proposed and it was seconded by Cllr. Jones, with all in favour to Co-Opt Mrs Harrison on to Council. Mrs Harrison signed the Declaration of Acceptance of Office.
